

# Person High School Band Boosters

## *Minutes from the January 11, 2010 Meeting*

The meeting was called to order at 7:40 P.M. by President, Rhonda Choquette. Meeting was held at the SMS Auditorium. Attendance was taken and the minutes from the previous meeting were read. A motion was made by Wanda Wilson and seconded by Angela Wells to accept the minutes with the necessary corrections. Motion carried.

The treasurer's report by Judi Akers- Balance Brought forward \$2899.85. The expenditures totaled \$1046.47 and income received \$1823.96. Balance as of 1/11/2010- \$3677.06. Pending expenses include \$175.55 fee for band website. There is still approximately \$2000 in outstanding band fees. This amount includes Band members and Color Guard. Mr. Robertson will follow up with a letter to the 21 members who still have not paid. The floor also agreed by consensus that Mr. Robertson would add a statement that indicates the possibility of grades being held if fee not paid.

### Old Business

**Rain Gear-** Andrea Childers had samples of ponchos and raincoats. The poncho could be purchased for \$4 and the raincoats at \$8. After discussion related to durability, a motion was made by Angela Wells and seconded by Roscoe Harris to purchase the raincoats at \$8. Motion carried.

**Advisor Stipend-** Mr. Robertson spoke with Mr. Hester and the school system will not be able to pay the stipend for the volunteer advisors for the drill team or color guard. The fee if maintained in the future will have to come from the Boosters. In order to assist with the fee, Mr. Robertson will speak with the Drill Team advisor about charging a fee to assist with stipend. He will follow up toward the end of the school term.

**TV Raffle Tickets-** Rhonda ordered the tickets today and will be distributed by Tuesday. The members will have about 2 ½ weeks to sell the tickets. One thousand tickets were ordered. The Secretary of the Student Officers will record the sign out of tickets. Tickets are \$5 each or 5 for \$20. The drawing will be held Feb. 3<sup>rd</sup>.

**Christmas Parade-** Cancelled due to snow.

**Website-** The website is up. The Wells are requesting pictures, video, etc. to go on the site. Mr. Robertson hopes to equip the site so that it could be used for individuals to post donations and pay fees. He would like to see the minutes, financial reports, etc. on the site as well. We might try selling advertisements on the website.

**Band Banner-** Andrea Childers checked on the banner. The body prefers that the banner is fabric and sewn. Volunteers are solicited to assist in shopping around for the best price for the type of banner desired. The fees so far range from \$800 to \$1200.

**Advertisement Payments, Band Awards, Constitution and By-laws, and the Trophy Case-** Discussions were tabled until next meeting.
